

The Preventive Welfare State: A Model for South Africa?

Panel coordinated by the Friedrich Ebert Foundation, South Africa Office



One of the key elements of the European Socio-Economic Model is the social welfare state in all its varieties. It has faced increasing difficulties after the end of the Cold War due to the pressure globalisation exerts on economic competitiveness and the costs of labour. Therefore, the traditional model of the welfare state has been questioned and scrutinised. Liberalists are in favour of cutting the services of the welfare state in order to reduce labour costs, favouring an individualistic model of risk-bearing.

But there is another school of thought arguing that the welfare state should not be cut down or abolished, but transformed to fit with the new economic environment. The socalled "preventive welfare state" differs from the traditional reactive, compensating and alimenting welfare state (usually based on a system of social grants) in that it wants to enable everyone to take part in the "first" economy and therefore to avoid having to be compensated with alimenting measures of the "reactive" welfare state. This should be achieved through a mixed system of activating, preventative and investing measures, emphasising the importance of life-long education in particular. Nevertheless, one has to acknowledge that there is still a need to retain certain elements of the reactive welfare state. The question remains, therefore, how to strike a balance between preventive and reactive features of a comprehensive welfare state.

The aim of the panel coordinated by FES South Africa Office is to discuss together with South African partners characteristics, questions on and future perspectives of the welfare state. A further aim is to explore in which way the concept of the preventive welfare state could influence future reforms of the South African welfare state and social security system.



Jos Berghman

Katholieke Universiteit Leuven (Belgium)

Jos Berghman is Professor of Social Policy at the Faculty of Social Sciences of Leuven University, Belgium and directs the international postgraduate 'Impalla' programme on social policy analysis.

Jos Berghman is President of the European Institute of Social Security and chairs the tripartite Supervisory Board of the Belgian Social Security System. He is member of editorial boards of several international journals on social security policy and of scientific award committees. His main research interests are comparative and European social security, social exclusion, social cohesion policies and social security policy information.

He has been an Advisor to the European Commission Directorate General for Social Affairs and to Eurostat, as well as to the governments of several EU Member States and to the Council of Europe. He is vice-president of the Luxembourg Centre d'études de politiques socio-économiques CEPS/INSTEAD and member of the Lisbon Agenda Group.

Rudi Dicks

National Labour and Economic Development Institute

Rudi Dicks is the newly appointed Director of the National Labour and Economic Development Institute (NALEDI).

Since the mid-1990s he has been promoting labour rights, at first in his capacity as coordinator in several sections of the Chemical, Energy, Paper, Printing, Wood and Allied Workers Union (CEPPWAWU) and until recently as the Labour Market Policy Co-ordinator for COSATU. In this capacity he was Alternative Labour representative on the CCMA Governing Body and a member of the Human Resource Sub Committee of the CCMA.

In between actively promoting worker's rights, Rudi Dicks acted as research co-ordinator for the Fair Share unit of the School of Government at the University of the Western Cape.

Mr. Dicks holds degrees in management from the University of the Witwatersrand and in economics from the University of London. As a literacy fieldworker in the early 1990s Rudi Dicks was responsible for introducing Adult Basic Education and Training projects to particular Cape Town townships.

Wiseman Magasela

Department of Social Development

Wiseman Magasela is the Deputy Director General at the National Department of Social Development. He heads the Social Policy Programme which was established to introduce and institutionalise evidence-based policy making in the social development sector. Critical to this initiative is the use of systematic research in the policy making process and the promotion of social policy as a way of thinking about and intervening on social challenges.

Prior to joining the Department of Social Development, Wiseman Magasela held the position of Research Manager at the Centre for the Analysis of South African Social Policy, University of Oxford, England. He lectured Sociology at the University of Natal (1991 - 1995) and at the University of Fort Hare (1996 - 1999).

Michael Masutha

MP, Committee Chairperson on Social Developpment

r Michael Masutha is a member of parliament for the ANC since 1999 and ANC House whip. He is the chairperson of the Parliamentary Committee for Social Development and the Review Sub-Committee on Rules, as well as being a member of the Joint Constitutional Review and the Judicial Service Commission.

Mr Masutha holds a LLB degree from the University of the Witwatersrand and a BJuris from the University of the North, and was admitted to practice as Advocate of the High Court (1995).

Mr Masutha has been a human rights lawyer in the early 1990s and an activist for the rights of the disabled, a field in which he has also published. Mr Masutha's interest is the empowerment of the poor and their decreasing vulnerability to poverty and racial exploitation, in particular consumer exploitation.

Marius Olivier

Centre for International and Comparative Labour and Social Security Law / University of Johannesburg

Professor Marius Olivier is Director of the Centre for International and Comparative Labour and Social Security Law (CICLASS) where he runs interdisciplinary projects on social security law and development law.

Prof. Olivier serves as a legal advisor and consultant on the national level such as the cabinet-appointed Committee of Inquiry into a Comprehensive System of Social Security for South Africa (2000-2002), and on the international level for the World Bank and institutions throughout Africa and parts of Asia. In addition, Professor Olivier chairs the SADC Core Group of Social Security Specialists, in this capacity being responsible for extensive social security initiatives in SADC.

He holds a LLB degree from the University of Pretoria and a LLD degree from the University of South Africa. He is a professor for Labour Law at the University of Johannesburg (former Rand Afrikaans University) since 1990. He also served as guest professor in Taiwan, Belgium, New Zealand and Germany.








Does Policy Convergence Strengthen or Weaken Regional Integration?

The Cases of Migration and Health Policies in the European Union.

Panel coordinated by the French Institute of South Africa



1. European migration policy:

For many analysts, Europe clearly lacks a unified migration policy and has been struggling to define one beyond cooperation around border control, thus favouring a state-centred approach. With both sending and receiving countries in its ranks and diverging perceptions of needs for and capacities in migration management, the definition of a common European migration policy seems a highly unlikely area for convergence. At the same time, since 2002, a number of steps have been taken to fast-track this convergence process. Some say the closing of borders and the externalisation of control are direct results of a common policy that is however lacking a strategic vision beyond security considerations. Is migration such a deeply sovereign sector of public intervention that its integration can only result in a narrow smallest common denominator?

2. European health policies:

The liberalisation of European health insurance systems exemplifies a case of 'soft' convergence under the combined effects of country to country instrument transfers and the influence of OECD experts. National adaptations and their multiple forms question the very notion of convergence and of the so-called 'europeanisation' of policies and highlight the capacity of national frameworks and networks to modify external/regional trends.



Marianne Berthod-Wurmser

Inspection Génerale des Affaires Sociales (France)

arianne Berthod-Wurmser is a member of the General Inspectorate of Social Affairs - a government body aimed at evaluating and controlling social policies and social public organisms in fields such as labour and employment, social protection, health and social services. Her training was in economics and political sciences.

In the course of her professional carrier, she has mostly been in government administration positions were her main functions had to do, in different ways, with "the contribution of academic expertise and research to reflections concerning public policies", for example at the French National Planning Commission in the 1980s and at the head of the 'research mission' of the Ministry of Health and Social Affairs in the 1990s. In these positions she had opportunities to develop comparative studies (seminars, research programs, collection of books...) between Europe and other comparable countries on health and social protection systems - developments which finally lead to large ongoing research programs with the support of the European Commission. She made some personal publications in the field, mostly in the decade between 1985 and 1995.

Mark Heywood

AIDS Law Project

Ark Heywood joined the AIDS Law Project in 1994, becoming project head in 1997. He has written numerous articles on AIDS, the law and human rights, and is a co-editor of HIV/AIDS and the Law. He assisted with the drafting of key human rights documents such as the Southern African Development Community (SADC) Code on HIV/AIDS and Employment and the United Nations International Guidelines on HIV/AIDS and Human Rights. He is National Secretary of the Treatment Action Campaign (TAC) and the Deputy Chair of the South African National AIDS Council (SANAC).

Mr Heywood received a BA Hons (Oxford) in English Language and Literature in 1986. Thereafter he was involved for a decade in the anti-apartheid struggle from London and later South Africa. Between 1990 and 1994 he completed his MA in African Literature (Wits).

Catherine Wihtol de Wenden

Centre d'Etude des Relations Internationales, CNRS, Science Po, Paris

Catherine Wihtol de Wenden, political scientist and lawyer by training, is research director at the CNRS (CERI), specialising in international migration. She has worked on migration in France and Europe, and on the globalisation of mobility, for almost thirty years. She has also studied the impact of migration on the redefining of national and European citizenship.

Department of Home Affairs


